1. RATES & TAXES

2. AGE REQUIREMENTS:

For Categories A, B & C: Minimum age: 21 y.o. For Categories D,E: Minimum age: 23 y.o.

3. DRIVING LICENSE & ID REQUIREMENTS:

All drivers must present a full valid driving license and a valid identity card or passport. All drivers should hold their driving license for a period of at least one year.
