Driver's Age Driver's License Minimum driver's age: 25 years old, maximum 75 yrs old. Minimum driver's age: 25 years old, maximum 75 yrs old.

Driver must have a valid driving license held for at least 12 months. For driving licenses that are not written in Latin or outside EU an international license is required.

Minimum Rental Taxes

Fuel Policy Traffic Fines

The renter must return the car at the same fuel level as he took it.

Tickets and subsequent administrative sanctions resulting from traffic violation during the rental period are at the renter's expense.

**COLLISION DAMAGE WAIVER (CDW)**

All our cars are provided with extra coverage (Collision Damage Waiver) with an excess (driver's risk) limited to 300€ or 750€.

The coverage is referred to the repair costs of the rented car in case of accident. It is valid only under the condition that the Greek driving code has not been violated.

During the rental a credit card guarantee is required for the excess. Categories A, B 300€ excess. Categories C, C1, F 500€ excess, Categories E, E1, F1 750€ excess.

**FULL DAMAGE WAIVER (FDW)**

All our cars can be rented with full coverage (Full Damage Waiver) with no excess at all (no driver's risk) that covers all the repair costs of the rented car in case of accident.

It is valid only under the condition that the Greek driving code has not been violated. FDW is optional and you can request it also at the delivery point.

The cost per day to benefit FDW for the categories A, B, B1 is 5€. For the categories C, C1 is 8€ and for the categories E, E1 is 10€. With this insurance no credit card guarantee is required during the rental.

**THIRD PARTY INSURANCE (TPI)**

TPI covers damages to third party and property

**TIRE COVERAGE**

The customer is not responsible for damage to the tires if he accepts and signs the relevant terms of the contract. The cost per day to benefit Tire coverage is 1.5€.

**INSTRUCTIONS- PROCEDURES IN CASE OF AN ACCIDENT**

- Contact immediately the car rental company. The phone numbers are written on the top of the rental agreement and they can be used 24hrs a day including weekends. • Contact the police.
- If there is an injury, report it to the police or contact directly the first aid emergency.
- Remain at the accident scene and do not admit liability or guilt until police or one of our representatives arrives.
- Obtain names and contact details of parties involved and the witnesses.

**WHEN NOT COVERED BY INSURANCE COVERAGE**

The insurance doesn't cover damages:

- Loss of the car Key
- To the interior, glasses and underneath the car.
- When the driver causes an accident under the influence of drugs or alcohol.
- If The driver of the vehicle is unauthorized from Auto-Kappa and therefore not included as a driver in the rental agreement.
- In cases of an accident when not followed from the driver all the procedures described in the above paragraph.
- If the renter doesn't take all the necessary precaution measures for secure parking and locking of the car.
- If the car is illegally parked.
- If the car has been driven off road (outside official driving network or any unpaved road).
